Certification Cycle:	The certificate is valid for one year. Before the expiration date of the certificate, a recertification audit is conducted in order to renew the validity of the certificate for the next year. The certification audit is carried out in two (2) stages. Stage 1 has to be implemented off-site and shall be fully justified. During Stage 1 the auditor reviews the results of the gluten analysis conducted to the products that will be certified. The evidence demonstrating that stage 1 objectives are fully achieved shall be provided. The interval between the two stages shall not exceed one month. If this period elapses or significant changes occur that affect the MS, stage 1 must be repeated. Stage 1 assessment findings may lead to postponement or cancellation of Stage 2. If nonconformities are found, they shall be closed until the conduction of stage 2. Audits shall be scheduled in the client's full operating period and cover a representative part of the scope. The site must be in gluten free production on the day of the audit, where appropriate. Audit planning and timetable. The Hellenic Society of Coeliacs undertakes the obligation to review the product declaration forms, the TÜV AUSTRIA certificate and the product analysis certificates submitted by the organization and judges whether the conditions for the organization's licensing are met. In case of a positive decision, it concludes that a contract with the organization and the right to use the CGT-crossed grain trademark is granted. The Hellenic Society of Coeliacs also undertakes the obligation to control the draft labels that will be used by the organization in the products.
